Motor vehicles – Driving schools – License granted for imparting instructions for hire or reward in driving motor vehicles – Owner of driving school deceased – Feasibility to allow transfer of ownership to the name of legal heir – Circular instructions issued – Extend the facility to transfer of ownership of driving school license of a disabled/ill health person to one of the qualified member entitled for legal heir ship during his life time also – instructions issued.

Instructions were already issued in the reference 1st cited to consider and allow transfer of driving school license to one of the legal heirs of the deceased holder of driving school license in the event of death of holder of such driving school license subject to production of all the relevant documents before the licensing authority for allowing such transfers.

The above circular instructions do not facilitate to allow/permit transfer of ownership of driving school license to one of the family member entitled for legal heir-ship during the lifetime of the driving school owner in the event of his/her attaining disability/ill- health, etc.

Now it is decided to extend the facility of transfer of ownership of the driving school licenses to one of the family members entitled to hold the legal heir ship in extra ordinary circumstances of attaining disability/ill health, etc., Subject to production of all relevant documents. The driving school owner who attains disability/ill-health, etc.., shall apply to the licensing authority concerned in which jurisdictions the driving school is functioning with relevant documents and Medical Certificate so as to prove his/her disability/ill-health, etc. With the following information:

- 2. On receipt of the application, the licensing authority must satisfy himself on the applications, the transfer of ownership is as a bonafide one. Then, if necessary, opportunity of personal hearing may be afforded to verify the genuineness of the request and send a proposal to the Joint Transport Commissioner / Deputy Transport Commissioner concerned along with relevant documents with his recommendations.
- 3. The Joint Transport Commissioner / Deputy Transport Commissioner concerned within a reasonable period shall scrutinize all the documents and after making such relevant enquires if necessary, forward the proposal to the Transport Commissioner Chennai with his specific recommendations about the transaction.

4. On receipt of proposal for from the Joint Transport Commissioner / Deputy Transport Commissioner concerned, final orders will be passed by the Transport Commissioner Chennai based on the recommendations of the Joint Transport Commissioner / Deputy Transport Commissioner concerned. On receipt of appropriate orders from this office action shall be taken to transfer of ownership of the driving school license within the provisions of rule 24 of Central Motor Vehicle Rules 1989 and Transport Commissioner's Circular No.62/2011.

The above said circular shall come into force with immediate effect.
