### ORDER:

In G.O. Ms.No.675, Home dated:3.6.98, the government issued draft amendment to sub Rule 4 of Rule 116 { B}and Rule 132 of Tamil Nadu Motor Vehicle, Rules, 1989, and invited objection and suggestion from the public. The same was also published in Tamil Nadu Government Gazette as Notification in S.R.O.NoA35/98 at page 106 of Part. III section 1(a) dated 8<sup>th</sup> July 1998. Since no objection or suggestions have been received from the public, the government have decided to confirm the above notification. The following notification will be published in the Tamil Nadu Government Gazette.

### NOTIFICATION

In exercise of the powers conferred by section 65 of the Motor Vehicles Act 1988 (Central Act 59 of 1988), the Governor of Tamil Nadu, hereby makes the following amendment to the Tamil Nadu Motor Vehicles Rules, 1989, the same having been published previously, as required by sub-section (1) of section 212 of the said Act.

### AMENDMENTS

In the said Rules, (1) in rule 116-B, in sub-rule (4) for the words 'one year', the words "Five Years" shall be substituted.



(2) In the Table under Rule 132, in serial No.9 in column (3) for the amount "1000/-", the amount "5000/-", shall be substituted.
